4. Criminal Records Bureau Check

As of 2012 Criminal Record Bureau checks are mandatory for **all** ARDS licensed instructors. Please provide a valid CRB disclosure number and date of issue. Your CRB disclosure must have been obtained via the recognised motorsport body (MSA) and is not transferable from a different sector. Your CRB check is valid for 3 years from the date of issue.

To apply for a CRB check through the MSA please complete a CRB application form (download at www.ards.co.uk or available from your sponsor school). This needs to be countersigned by your sponsor school and returned directly to the MSA. The check costs £36, do not send payment at this stage, your sponsor school will collect your payment on completion. You may forward your ARDS application to us pending completion of your CRB check, the MSA will notify ARDS directly once your disclosure is through.
